Initial Prayer & Blessing by Conductor (Cece Charles)

Cece [2:33]: Dear father, mother God. We ask thy blessings on this gathering. We ask love, strength, guidance and blessings on this channel, his guides, and also special blessing for all those present for this channeling, asking full well knowing, so shall it be. We thank thee Father.

Source [3:05]: “We have the channel at this time ... and the references associated with the questions to be asked. You may proceed.”

Cece [3:23]: Thank you for coming to join us again this evening, we surely do appreciate it. Today’s date is Thursday December 22nd, 2011 at (state the time), and this *Year End Channeled Message* session is being conducted at the home of Mrs. Sandra Strauss. The purpose of this gathering is to provide guidance regarding the upcoming New Year (2012) for members of the channel’s *Indigos & Sensitive’s Support Groups*, his *Search For God Study Group* and his *Dreams & Spiritual Discussion Group*.

Source [3:57]: “We have the references associated with same.”

Prepared Questions

Cece [4:04]: OK, we’ll go ahead and begin. The following questions have been compiled and organized by the channel from questions that he received from various group members of his *Indigos & Sensitive’s Support Group* in Fairfax, Virginia and Lima, Peru, various members of his *Search For God Study Group* in Fairfax, Virginia also the members of his *Dreams & Spiritual Discussion Group* in Tucson, AZ.

We ask that full, complete and comprehensive answers be given in such a manner that ALL members of this gathering will be able to clearly understand these answers. We ask that the information be as specific as appropriate for this channel, various members present, as well as for all those who will read the transcript that the channel will prepare following this channeled session.

Source [4:53]: “We will attempt to answer questions clearly but it will require understanding and effort on the part of those listening and/or reading.”

FFX Indigos & Sensitive’s Support Group

Cece [5:09]: Thank you. Our first set of questions concerns the *Indigos & Sensitive’s Support Groups* in Fairfax, VA and Lima, Peru.

Q1) This is a two-part question. And for Question 1, the first part is, “Is the open discussion meeting format of the Fairfax, VA *Indigos & Sensitive’s Support Group* where individuals other than the channel volunteer to conduct & facilitate the meetings, the best format for the Spiritual & Psychic Development and Growth of the individuals in these gatherings?” The second part is, “[Should] some or all of the meetings include discussion of specific topics or books or experiential exercises?”

Source [5:52]: “We will answer the questions in reverse order. Clearly an understanding and a discussion of book topics and/or subjects of interest to other members of the grouping, as well as experiential exercises are clearly beneficial. And of those that have been carried out, great value has been obtained and gained by those for who participated.

As for the format of individual group members within the gathering take [taking] responsibility for facilitating the meetings, it is most appropriate. For the channel has done all of the preparatory work necessary to hand over this responsibility to individual members of this gathering. That is a responsibility as well as an honor for each of them. You may continue that format. Do you understand?

Cece [7:12]: Yes we do, thank you. Question 2....

Q2) Is the *Ideal*¹ that was originally created for the *Indigos & Sensitive’s Support Group* by the channel (Lowell) still the appropriate *Ideal* for this grouping? And if not, can you provide some required changes or guiding words that might be incorporated into the new *Ideal*?

Source [7:36]: The *Ideal*, as articulated by the channel to other group members, it has been written and given to them, is the most appropriate *Ideal* for this gathering/grouping at the present time.

Cece [7:59]: OK (very softly) Question 3....

Q3) Is the channel conducting sufficient Spiritual & Psychic Development classes and exercises or does he need to create more classes and/or exercises to expand the Spiritual & Psychic awareness and capabilities of the individuals in these groups?

Source [8:21]: We honor & acknowledge the channel for being so bold as to ask that question, for he knew full well that the answer is more appropriate for [directed at] the individuals in this gathering than for him and his own understanding. Clearly additional training opportunities, additional exercises, wherein each individual is challenged and expanded in their own understanding, is very beneficial. Not just to the individuals, but to all of the individual contacts that that individual makes on a daily basis. For these processes allow the channel to impart an understanding of the responsibility as well as the honor and opportunity of utilizing one's psychic abilities and their spiritual understandings to benefit the mankind that we get the opportunity to interact with. Do you understand?

Cece [9:35]: Yes, thank you. Question 4....

Q4) Is there any specific advice that you have for members or individuals of the Fairfax *Indigos & Sensitive's Support Group*?

Source [9:54]: There is but one simple caution that the channel continually repeats at several of the gatherings, and that caution is, "the opportunity to express one's psychic sensitivity must not be used as an avenue of [for] setting one's self apart in an egocentric manner, but in fact humbly expressed and be grateful to the Universe for allowing your ability, as well as allowing you the opportunity to express." Do you understand?

Cece [10:37]: Yes, thank you. Question 5....

Q5) This is another two-part question. The first part is, Is the format and conduct of the Chanting at the end of each Fairfax *Indigos & Sensitive's Support Group* gathering still the most appropriate way or manner of creating healing energy for the planet and its inhabitants, or does it need adjusting based on the members present and the shifting energy of the human consciousness? The second part is, Will the Source please provide a detailed explanation of the purpose & effectiveness of this Chanting process for the enlightenment and understanding of members of this gathering as well as others who will read the response?

Source [11:27]: The chanting process that the group has been doing, and has been aware of the necessity of carrying out, is indeed a very powerful process creating enlightenment for many who we do not know, or whom the energies within those gatherings may not recognize or do not know. That energy is effective in raising the consciousness, and/or the consciousness level awareness of individuals in multiple dimensional realities, not simply within this dimensional reality. It needs to be understood that when the channel was given the information to do the Chanting and to create an energetic vibration, which he then, and other group members then, create and multiply to create an energetic healing that goes out to individuals, is much more powerful than simply the words that you use.

There are individuals within the grouping that are capable of becoming aware of the palpable energy that is created as part of that process. There are others who simply participate believing that they must be a part of a group. That energy creates a great realm of vibration at multiple levels of consciousness and does indeed affect the ‘mankind consciousness evolution process’. Is that clearly understood?

Cece [13:37]: Yes it is. Thank you. Question 6....

Q6) Are the Spontaneous Channeling sessions by this channel (Lowell) that occur at many of the Fairfax meetings necessary and helpful to the Spiritual & Psychic Development of the group members as well as the channel?

Source [14:00]: The Spontaneous Channeling processes that the channel allows to experience and/or to express, is for the benefit of those members present in each of those gatherings. The channel himself does not know when he will actually do those Spontaneous Channeling’s. Sometimes he believes he will not, when in fact he is forced out of his body and that channeling information is necessary to come through. The Council of Archangelic energies, of which we are a member, is part of that process that creates that energy that both allows that channel, as well as offers that channel, the ability to bring forth information that is of usefulness to the members of the gathering. So yes it is useful and beneficial, not only to members of the gathering but to the channel himself for it is in alignment with the purpose for which he came into this earth plane. Do you understand?

Cece [15:26]: Yes we do, thank you. Question 7....

Q7) Some members of the Fairfax *Indigos & Sensitive's Support Group* have expressed an interest in Lowell conducting a Channeling training exercise or workshop to allow them to channel. Is this something that Lowell needs to carry out and can the Source provide any guidance and/or cautions around such classes and training?

Source [15:53]: The expression of desire on the part of those individuals asking about Channeling and about the ability to channel and the training thereof, has both two cautions as well as two very primary helpful processes.

The cautions are, the ability to understand, not just at the conscious level, but at the deep subconscious level, of the need to be protective of one's energy when one does this process. For the channel himself opened his energies to entities that were not the most beneficial to him in his early processes. So he has learned this process and can teach that process to others, but the caution is [that] the individuals partaking must commit themselves to be as protective of themselves and less exploratory initially. Exploration is helpful later on but initially great protection must be made. If there is a great need on the part of entities, and they desire to create that process, they can do so and the channel will respond appropriately. Do you understand?

NOTE: The source said that there were two cautions and two primary helpful processes. The transcripts indicates that the *1st caution* is the need to understand the importance of protecting one's self from energies that are not of the highest level. The *2nd caution* is not as clearly stated but it is that "individuals partaking must commit themselves to be as protective of themselves and less exploratory initially". The Source does not state the two helpful processes, but I can tell you that the *1st helpful process* is that learning how to channel will increase your sensitivities and the *2nd helpful process* is that it will increase your confidence in interpretation of information you receive, either in a channeled state or in your waking conscious state.

Cece [17:40]: Yes we do, thank you. Question 8....

Lima, Peru Indigos & Sensitive's Support Group

Q8) Is the meeting format of the Lima, Peru *Indigos & Sensitive's Support Group* whereby the channel Skype's into the group and attempts to answer Spiritual and Philosophical questions for members of those gatherings and/or does mini-readings for the individuals in each

meeting, the most appropriate format for those meetings or should a different format be created? If so, does the Source have any guidance that you can provide?

Source [18:15]: The channel in his desire to be helpful to those individuals who are at a significant distance, has appropriately used the technological processes to allow him to communicate both visually and verbally with members of the Peru gathering. However, the process as it currently is existing consists primarily of the channel asking questions of the individuals as to what is going on with them and then doing mini-readings and providing spiritual guidance and counseling. Although [this is] beneficial and helpful to the individuals through for whom he counsels – they gain insights, they gain understandings, but without the necessary feedback on their part, due to their own cautions, etc. it is simply a helpful thing at the moment but not completely beneficial for their expansion of understanding. Needs to be a much more interactive, proactive process on their part, not simply waiting for the channel to answer questions. Often times the channel will probe someone knowing that they have a question but are unwilling to ask it. That needs to change, for the channels usefulness is being tested in this regard. Do you understand?

Cece [20:11]: Yes

Q9) Should the channel arrange to go to Lima, Peru and teach a class on Spiritual & Psychic Development and also do a book signing? If so, how & when should this trip be carried out? Is this trip necessary and would it be significantly or only marginally beneficial to the *Indigos & Sensitive's Support Group* members or others who might attend such gathering?

Source [20:38]: Although the intent of the channel [is] to be a blessing to those individuals, and to create a workshop that would expand their understanding, developmentally thereof, and express their experiential processes, psychic in nature, would be beneficial to individuals, [and] would be in alignment with the channel's process of being a guide to those throughout the world. However, it must be a commitment on the part of those individuals for them to desire to create a gathering sufficiently in size to allow it to be economically as well as spiritually advanceable for the individuals partaking in same. Do you understand that answer?

Cece [20:41]: Yes. Question 10....

Q10) Is there any additional information that the Source has for members of the groups in Fairfax, VA or Lima, Peru?

Source [21:58]: Although it is clear in the channel's mind, it needs to be stated more emphatically here, that the *Ideal* that the channel holds for these groupings is pre-eminent within his mind. It is [however] not pre-eminent within the minds of all members of that gathering. Curiosity is not a bad thing, but curiosity in terms of spiritual development needs to be expressed and explored and just like when you go to a school, you must study, you must learn, you must prepare yourself to take the tests that are necessary. The tests in these cases are daily tests of opportunities of being challenged, with opportunities to be the expression that the channel says you are capable of being, with every individual you contact day-by-day. If at the end of your day, you can methodically go through a checklist as it were of everyone you meet, and everyone that you glanced at, and can consciously say to yourself, "I blessed each and every individual that I had the opportunity to make some form of contact", then you have done your part. But that is the level of commitment that is required of all of these groupings, for that is the commitment of the channel himself. Do you understand?

Cece [23:57]: Yes we do, thank you. The next set of questions concerns the *Search For God Study Group* in Fairfax, VA. Question 11....

FFX SFG Study Group

Q11) Is the meeting format for the *SFG Study Group* where Lowell and other individuals within the group choose a book or topic to study and then either read and discuss the book or select "random" passages from the book that is being discussed, the most appropriate format for these gatherings? If not, will the Source please provide some guidance or suggestions that might create a better format to assist in helping each member of the grouping to create a better relationship with the Creative force or God.

Source [24:40]: We would restate the question and restate [provide] an answer that would perhaps be more appropriate for the individuals of that gathering. The *Search For God Study Group* as it was initially intended was to follow the format as outlined in the Search For God program of the Association of Research & Enlightenment whereby the Search For God Study Group books that were created by the original Search For God Program are used as guidelines, as tools, to understand the spiritual laws that came forth in the series of readings known as the 262 series for the original

study group. Those readings and the information contained in them, become somewhat burdensome to many for it requires a tremendous dedication at understanding spirituality, not simply information, and therein is part of the difficulty. For the inquiring minds of many members of that gathering want to know more yet they want to know it at the surface level rather than at the in-depth level. The channel has allowed himself to go along with that process where at least they get exposed to information. His desire would be to create a Ph.D. kind of program rather than a first level class program but that is not what the gathering is intent upon. So therefore, is the grouping appropriate? For the group members present, yes. Is it the most appropriate way for the maximum advancement of understanding and spiritual advancement? We would say no. Do you understand?

Cece [26:59]: Yes we do, thank you.

Q12) Is the *Ideal* that was originally created for the *SFG Study Group* several years ago by members of that gathering still appropriate? And if not, can the Source provide some required changes or guiding words that might be incorporated into the new *Ideal*?

Source [27:20]: The original *Ideals*, and there are three, that the original group created was part of a process that came out of the Search For God material. It stated that an *Ideal* both Physical in nature, Mental in nature, and Spiritual in nature needed to be created. That grouping went through a process that required an entire evening of discussion about what the *Ideal* should be for each of those areas. And through much discussion it was created based upon an understanding that at that point in time we [they] were studying the Universal Laws, or shall we say the channel was helping people understand Universal Laws as a concept and as a principle, both actively in your [their] mind as well as actively within our [their] physical environment. That is, how to utilize those Universal principles in everyday activities and relationships. That is the *Ideal* that the original group founded. If an *Ideal* different from that is desired, a similar process would be appropriate for the grouping to come up with the *Ideal* they choose to create for that grouping. That is a dynamic thing, not a static thing. So that is the answer we provide for this [question]. Do you understand?

Cece [29:13]: Yes, thank you. Question 13....

Q13) Is there any specific advice or other information that the Source has for members of the *Search For God Study Group*?

Source [29:31]: As the channel has often said, one must be vigilant in their pursuit of truth, Spiritual in nature, Mental in nature, and expressed in a Physical manner as well. One cannot hold principles in their mind and yet in their daily activity not implement those principles, and recognize that they are being held responsible for acting on those principles they send [say], they claim to hold within their mind. It is not a trivial thing to govern ones life from a Spiritual perspective for it requires a great effort, regardless of how spiritually advanced you might be. It requires a great effort to get one's self ego out of the way and recognize that you are a servant of the most high serving others who are also of the most high. You must acknowledge that most highness within them in spite of the pettiness they might be expressing in physical form. Do you understand?

Cece [31:02]: Yes, thank you. The next set of questions concerns the *Dreams & Spiritual Discussion Group* in Tucson, AZ. Question 14....

Tucson Dreams & Spiritual Discussion Group

Q14) Are the meeting format guidelines that the channel created and provided to the group members, the most appropriate format for those in Tucson, AZ gatherings? If not, will the Source please provide some guidance and/or suggestions that might create a better format to assist each member of those gatherings feel more empowered in analyzing and understanding their own dreams.

Source [31:39]: The guidelines as [that] the channel created for that gathering were created because he knew that he was not going to be present to be able to train those individuals in learning how to conduct a Spiritual Discussion Group around the process of Dreams analysis. Therefore, he created a verbatim process that humorously is followed verbatim by the facilitators of that grouping. The last time the channel was present [with the Tucson group] and created a process. During that process a Spontaneous Channeling activity occurred and the channel brought forth information that stated, “the process must not be followed in a mechanical manner, but must be followed from a Spiritual understanding manner.” The words are simply guidelines for the individuals who are facilitating the process for them to follow [they are to follow] their own intuitive nature as well. The present process does not provide sufficient training in knowing how to interpret dreams. But the channel has been given the gift of interpretation, much as Joseph was given the interpretation many, many years ago. The channel has that ability and has lovingly shared that ability with the individuals of that

gathering as well as individuals of other gatherings the channel has been partaking in. So we would say the appropriate format is to follow those guidelines but follow them from the heart rather than from the letter of the law. That would be our response to your question. Do you understand?

Cece [33:58]: Yes.

Q15) Is the process where the channel Skype's into the group meetings and listens to and analyzes the group member's dreams, the most appropriate format for these gatherings? And if not, will the Source please provide some guidance and/or suggestions that might create a better format to assist in helping each member of those gatherings become better at analyzing & understanding their own dream AND advancing or expanding their own Spiritual Awareness or Consciousness?

Source [34:30]: The channel in his effortfulness to be of service and to be helpful to the members of that gathering, has allowed himself to fall into the role of the primary interpreter of the individual dreams that are expressed. It is understood, yet the individuals of that gathering are not taking on the role of attempting to understand the rationale and the reasoning beyond [behind] the symbolic interpretation of the various dreams that are being interpreted. Even though the channel takes the time to ask the individuals whether they understand why he interpreted a particular dream in a particular manner, although the nodding of the heads and the affirmations of the words it still does not create an understanding, simply an acknowledgement that the channel was correct in his interpretation. That would need to change for them to get a greater understanding of their own dreams so that they can begin to interpret their own dreams more appropriately and simply get confirmation from the channel. There are individuals within that gathering that are at that level of understanding and that simply needs to be expanded. Do you understand?

Cece [36:20]: Yes. Are there...

Q16) Are there other specific exercises or practices that the Tucson group or members within this group should be doing to advance or raise their own consciousness or awareness? (DG)

Source [36:34]: It would be appropriate for individuals within that gathering to be assigned reading assignments regarding dream interpretation, both Jungian dream interpretation as well as Edgar Cayce interpretations,

which is very similar in nature to that format. The channel needs to assign reading assignments and books to be read to help advance the understanding of individuals within that gathering. Do you understand?

Cece [37:15]: Yes, thank you. And is there...

Q17) And is there any other specific advice or additional information that the Source has for members of the Tucson group?

Source [37:24]: Not at this time.

Cece [37:26]: OK, thank you. The next set of questions concern the end of the Mayan Long Count Calendar and the Winter Solstice on December 20-21, 2012, the associated Galactic Plane alignment, and the many diverse predictions regarding that date. Question 18...

General Questions Related to 2012

Q18) The channel (Lowell) has stated that the end of the Mayan Long Count Calendar marks a shift or elevation in consciousness of humanity to a more or of a higher Spiritual Awareness more than it marks the beginning of major geological change that some have predicted. Can the Source validate or comment on Lowell's statement and/or will this Source please provide a more clear explanation of exactly what the end of the Mayan Long Count Calendar represents and what we as individuals within this gathering and other beings throughout the planet can expect to happen on December 20, 2012 and in the days, weeks and months that follow that Winter Solstice event?

Source [38:32]: The entity the channel, now expressing as the entity you know as Lowell was in fact one of those Mayan priests who were initiating shall we say, part of the creation of the Mayan calendar system, including the Long Count calendar. He has intimate knowledge at the subconscious level, at the soul level shall we say, of information he himself does not completely understand, yet is aware of [that] information and his lack of understanding thereof.

The end of the Mayan Long Count Calendar is [marks] the end of a period of understanding that the Mayan people captured in stone and other edifices information that would allow enlightenment to be carried through [the] ages. As many have understood and written about, this is simply the ending of one of those ages and the entity the channel understands that at a very fundamental level. It is in fact disconcerting to many of you that the channel

is not careful or concerned about the ending of his existence, for he clearly understands his existence is simply [a] temporal thing expressing in the channel entity as Lowell. His understanding [about the Mayan calendar] is more important to be conveyed though. And that is an understanding that the end of the Mayan calendar simply marks a change in understanding, a change in consciousness level as a result of many thousands of years of effort on the part of many peoples to raise the consciousness of humanity. This [the end of the Mayan calendar] is simply a mark in time, what we call time, or what the peoples of this earth call time and space, marking this end in change in consciousness. This marking coincides with a both geological and geophysical changes that have been, will continue, and in fact will be increased over the next 3 to 5 years. The actual change in understanding [that will take place] on the winter solstice, there will be an energetic shift that will be palpably present, it will be palpably understood, it will be manifested. Many people will become aware of a shift, will not understand that awareness, will not understand what that shift is all about, yet they will perceive a change in energy that they will not be able to identify with, or be able to explain. The channel himself will more than likely, based upon his present understanding, be aware of it yet not really fully understand it. It is [will be] geological, there will be geological changes, there will be some catastrophic changes. Some of you, or this channel himself, could possibly be involved in those. Fear not however, for the Christ is present in the midst of all of this. Do you completely understand what this process is all about?

Cece [43:05]: Yes, thank you. Question 19 consists of...

Q19) Consists of several sub-questions. I will ask the entire set of questions and ask that the Source respond to each of the questions individually.

- a) Some people believe that a “good or benevolent” E.T.’s are helping humanity to progress into higher consciousness. Is this true and is there anything we as individuals and as a group can do to help the E.T.’s help us? (YG)

Source [43:33]: We will address that question directly. The understanding of what you call E.T.’s or extra terrestrial awarenences are expressions of consciousness, not in human form but in other life living processes in different formats. They have existed, they continue to exist, some walk among us, when I say us meaning the channel. The channel has been aware of some of their presences, not actively so in the sense of being able to identify [them], but has been aware in their change in presence. Their

increased in energy. [The channel] has been helpful to several people whom he has done reading for regarding their own personal E.T. experiences shall we say. So as far as, “will the E.T.’s be helpful in this process, or be made more manifest as a result of the 2012 shifting?” It can be stated that their awareness has been here, their presence has been and continues to be here. Our ability to perceive them, our ability to begin to understand them, will be raised as a result in this change and shift in consciousness. But it does not mean that they will begin walking in the streets as E.T.’s as we know them [as the media/movies have presented them]. Do you understand?

Cece [45:34]: Yes, thank you. Besides prayer...

- b) Besides prayer and meditation are there any additional steps, exercises and practices or attitudes to be held by members of this gathering (and others) from now until whenever that would be effective in helping ourselves and our selves, as well as the animal & plant kingdom 'beings' prepare for what is to transpire prior to, at, and after the Winter Solstice of December 20, 2012? If so, we ask that the Source please be specific of what these actions are and if appropriate specific, to specific individuals including the channel.

Source [46:12]: We will address this in a multi-part answer. Each of thee, because you are a part of this gathering, has subconsciously made a commitment, not simply a commitment of curiosity but a commitment of responsibility of being a light to all of those you contact day-by-day. The channel has himself expressed this very well on several different occasions, we are [simply] re-expressing it more emphatically now. His words are simply not idle words but words to be taken [in and] accounted for, to be understood. There absolutely is a responsibility, on the part of each of thee, to be the light to the world in the world that you interact with on a daily basis. That is not a question, that is a commitment that you yourself as part of this process have committed to step up to do. You are the only one that evaluates that, but that is your commitment. Do you understand?

Cece [47:49]: Yes. Some people say that...

- c) Some people say that the worst is over economically and geologically in terms of dramatic shifts for 2012. Will the Source please comment on this statement? (YG)

Source [48:05]: It depends upon whether you have been personally affected [as to] whether it is the worst or not. For the worst for some has [already] in

fact taken place. The worst for others is yet to take place. So we would not say for one to take a commitment of attitude that “while [since] the worst is over, I don’t have to worry”. You do not have to worry but you do have to pray, and you do have to hold a consciousness of “Not my will but Thine”. If you are affected then you are affected, and simply ask for an understanding of what to do about that affecting. Do you understand?

Cece [48:56]: Yes, thank you. Individuals in the Lima, Peru...

- d) Individuals in the Lima, Peru group want to know whether the land of, and people of, Peru are to play an important role in the 2012 shift? Also, what actions can the *Indigo & Sensitive’s Support Group* in Peru do to be of help throughout this process? (FP)

Source [49:22]: This gathering that is addressing this group [the council ?] understands the concerns of the people in the Peruvian group. The land of Peru will be one of those lands that will be affected in a significant way as part of the geological changes that are in process and are to come about. It is not stated to create fear within individuals, [but] simply stated in terms of an understanding of preparation. Fear not for the Christ is with thee. But also prepare for in the event that a geological process were to occur and you were to be there, you would need to be able to survive that process, if that is what you choose to do. If you have a family and the responsibility of being the leader of that family, you have a responsibility and a commitment on yourself to that family. But fear not, but simply pray and be prepared as best you can.

There are areas within the United States as well that will also be affected in similar manner, or in similar ways. It is not for this Source to provide information that will prevent individuals from partaking in that process, but simply provide information that says you have the opportunity of being a catalyst for bringing loving, caring change to the world. If you are part of a catastrophic process then ask for forgiveness and ask for blessings and be honored that you are part of that process. That is the answer we are being provided or told to provide to this gathering. Is that sufficient for you?

Q20) The channel as well as many other psychics throughout the world has stated, “the veil between the physical world and the ‘inner planes’ has been thinning”. Will the Source please explain what exactly does “thinning of the veil” really mean for individuals in this gathering and

to individuals throughout the planet, and is Lowell correct in making this statement?

Source [52:21]: The entity the channel, whom you know as Lowell, is correct in stating that the veil of consciousness between, the veil between the conscious mind and the subconscious, or inner planes existence is indeed becoming very, very thin. It was much thicker, much more dense, much more difficult to transpire and to trans pass through [penetrate] when he was a young child, yet he was capable of passing through that veil and gaining understanding. It is almost transparent for this individual at the present time and it will become much more transparent as time progresses. There are many within this gathering who have a subconscious awareness of this ‘thinning of the veil’. To some of you it is somewhat frightening for it allows you to experience, to see, to sense, information that is not understanding or understood by yourself. Fear not, but be open to the awareness that it has the potential of making you aware of. Source [54:57]: The process known as the winter solstice of 2012, marking the end of the Mayan Long Count Calendar, has received significant increased interest over the past years. That interest will significantly increase over this next year. There will be much media speculation, much media distortion of information. It is your responsibility to be proactive in expressing your understanding of the shift in consciousness and not minimize but express an understanding that although there will be geological, geophysical, environmental in nature sometimes, changes, some of which will be shall we say catastrophic, catastrophic to the individuals that are part of that process, interesting to those who are not part of the process. Source [58:38]: The entity the channel and the entity who questions have been in multiple past lives together as have several other members of that gathering been associated with the entity the channel as well as with each other. Bart [1:00:34]: James Anthony Bartelloni. Two years ago the council told us in a channeled session that Osama Ben Laden [was] in fact dead and had left the earth plane. Obviously within the past year the United States Government is claiming that they in fact were the ones who took him from this earth plane. Can you let us know what the real scoop is there? And if there is any discrepancy in that, what happened?

Source [1:01:08]: When the question was asked of the channel. The question was whether the entity Osama Ben Laden was in physical form and was a viable force within the environment that he was working. It was stated that he was not a viable force within the environment within which he was working. And it implied that he was physically not in present form. From this level of understanding [awareness or consciousness], the physical body, the person Osama Ben Laden was existing in at the time that information was obtained, was in perilously close to being shall we say discarnate in nature. The information was given with the understanding that he was not the viable force within the organization. He did in fact recover from that process and as a result he became shall we say a side line person. He was not the person with whom the entity that was asking the question was concerned about, but his physical existence was in fact in physical form. So when the United States individuals, military in nature, discovered that his physical being was still in existence, they took out [carried out] the process whereby they eliminated his physical presence and buried his physical presence in the ocean. Source [1:05:00]: The entity referred to as Suzanne, asking this question. The entity asking the question is connected in an energetic fashion to those entities, to some of those entities, who are expressing in what we would call Extra Terrestrial form, for you were a part of that expression in previous existences.
